



# **National President's Report**

This has been a big year for us as we celebrated our 10 year anniversary. From humble beginnings with 50 members in Victoria to around 1300 Nationally and with branches across each State and Territory, we have come a long way.

Not only have we grown in size, but our advocacy has seen an impact in creating more diversity in the legal profession as well as greater access to justice.

Nationally for us, the biggest project was organising and hosting our 10 year anniversary gala in Melbourne. With over 250 attendees from across the country, including many distinguished guests comprising Judges, MPs (both State and Federal), Commissioners, media, law firms, Bars associations, Law Councils, and our members, it was a night of celebration and taking stock of what we have achieved in the last 10 years. Our Keynote Speaker was MasterChef Kishwar Chowdhary who shared her journey as a person of diverse background in an Anglo male industry.

We also had a panel comprising past and current Presidents who shared why they started/joined AALA, as well as what they achieved in their tenures.

We have been active in our advocacy both at the National and State Level. I was interviewed/quoted in a number of media articles and have spoken at various forums.

Our scholarship program, sponsored by Maddocks and in partnership with Melbourne Law School and the Victorian Bar, went into its 6<sup>th</sup> year, again attracting a number of high-quality papers. The launch event was held at the Owen Dixon Chambers with keynote speaker Liz Bennett SC and the award ceremony was held at ACT Supreme Court with Hon Justice Chrissa Loukas-Karlsson of the Supreme Court of ACT as the keynote speaker. The joint winners of this year's essay were Amber Meyer and Arden Yeh for their paper, *The Law, Equality and Anti-Discrimination.* We will continue to support our younger members in their endeavours to create greater cultural diversity in the legal profession.

Our mentoring program which we ran again this year, paired mentees with senior members of our profession, including from the judiciary. Though a National initiative, each Branch coordinates the launch events, pairing and managing the program in their State/Territory. Our mentoring program benefits both mentors and mentees.

Our Branches have been very active and have held numerous events and initiatives that have been enjoyed/benefitted our membership. I attended and spoke at some of the events and really enjoyed interacting with our members. I would like to thank all the Branch Office Bearers and Committees for keeping the Branches active and engaging in meaningful initiatives.

I would also like to thank the National Executive office bearers, particularly the Vice President Catherine Chang, Secretary Jake Huang and Treasurer, Ivonne Muryadi. Their dedication towards AALA is commendable and their efforts have enabled us to undertake many of our initiatives and provide support to our Branches.

I also want to thank you all for allowing me to serve you as the President. I conclude my second term as National President and complete 10 years in the Executive, serving earlier as Treasurer and Vice President. # National Treasurer's Report

This is my second term as National Treasurer and I am truly honoured to work alongside Molina Asthana, Catherine Chiang, Jake Huang and all of our Executive Committees. Together, we have worked on various objectives and will continue with many more initiatives for our future generations.

2023 is a very special year as we celebrate our 10 year anniversary together with our members (individual and corporate), sponsors, partners and volunteers who have been supporting and working with us throughout the years. Reflecting on our journey and past achievements, I believe that together we can achieve greater outcome in cultural diversity in the law profession.

Key achievements in 2023:

- Establishment of ICT Subcommittee
   It is important to have ICT team to strengthen
   our technology infrastructure and security to
   protect our data and to work efficiently with
   our stakeholders.
- <u>Completed Performance Report</u>
   The aim of performance report is to provide transparency to the National Executive Committees regarding income and expenditure of all branches which also include number of events held and members. This performance report can also help branches to monitor progress.
- <u>Created a simplified budget report</u>
   This is to assist National Executive
   Committee to better understand our association source of revenue, operating expenses and events related expenses.

For the financial year 2022/2023, I have worked on a number of initiatives to advance our association financial statements position in compliance with various Accounting Standards implementing by actioning and the recommendations by our auditor, Walker Wayland Advantage. I am pleased to present 2022/2023 Financial Statements with unqualified audit opinion report and Annual Report together with our Executive Committees and Branch Committees. Our financial position for 2022/20223 financial year remains favourable despite the loss position.

Key points of our financial position as follows:

- Financial position remains solvent and healthy with liquidity ratio above 1.
- Cash position is in positive which allows our association to continue its operation and able to pay its debts as and when they become due and payable.
- Total revenue of \$123,985 which is an increase of 16% relative to 2021/2022 financial year. Major movement is in relation to sponsorship and events ticket sales revenue.
- Total expense of \$136,555 which is an increase of 37% relative to 2021/2022 financial year. Major movement is in relation to an increase in function and events costs as we continue to hold more in-person events in 2022/2023 financial year.
- Loss of \$12,570 for this particular financial year which reduced our retained surplus down to \$84,713 from \$97,283 in financial year 2021/2022. Major movement is in relation to a change of methodology in reporting income. In the past financial years, membership fees and sponsorship income were all recorded as income in Income Statement. However, in financial year 2022/2023. we have implemented recommendation from the auditor to separate membership fees and sponsorship income for future financial year and record them as Deferred Income in the Balance Sheet. Total of actual membership fees received in financial year 2022/2023 is \$42,936 and sponsorship income is \$53,928. It is expected that the loss to incur only in the first year of the changed of the methodology.

The above highlights of our financial statements are evidence that our association is a genuine community organisation. Revenue received by our association are used to funds association objectives' activities and events for our members. I thank our National Executive Committees and Branch Committees for their time and effort throughout the year and especially for their assistance to work through the auditor's recommendation and be able to achieve a clean unqualified audit opinion report.



As always, I am looking forward to the promising future of our association and will continue to improve our association financial position. I am grateful for the enduring support and would like to thank our members (individual and corporate), sponsors, partners, volunteers and also Walker Wayland Advantage. Walker Wayland Advantage has been supporting our association with their expertise in audit and financial statements preparation.

# New South Wales Branch Report

The 2023 NSW Annual Branch Meeting was hosted by Gilchrist Connell at their offices. We therefore acknowledge the Gadigal people of the Eora nation as the traditional owners of Warrang, the location eventually known as Sydney, and pay respects to their elders, past, present and emerging, as well as elders of recent arrivals.

In preparing for this Report, I reflected on our previous submissions. In these Reports, my colleague and Immediate Past President, Marija Yelavich reflected on the pandemic and the impact that it has had on the state and the legal industry and practice. While the pandemic did continue throughout 2023 and we can confidently say that COVID remains part of our daily lives, our society has learned to co-exist and thankfully, has opened up. This year has been a particularly poignant year for those of us who are in the diversity and inclusion space with the Voice Referendum that occurred on 14 October 2023. Echoing the National Executive Committee's statement made earlier this year, we stand in solidarity with First Nations people who sought to constitutionally recognise the proposed Aboriginal and Torres Strait Islander Voice, as proposed in the Uluru Statement from the Heart. Though the referendum was unsuccessful and caused many divides across the Australian community, it highlighted for diversity and inclusion organisations like AALA, the importance of continued efforts to educate, engage and advocate for fair and equitable access to justice and representation to all Australians, particularly those most vulnerable and marginalised.

On this note, I am confident that 2024 will be a vear of renewed strength for the NSW Branch where we are looking at furthering research and policy advances. As the continuing President, the new year will welcome with it some new faces in the Executive Team and new faces in the Committee. Diversity of culture is central to AALA, but equally important is diversity of thought and elevating Asian leadership. In joining the table of 40 under 40 Alumni winners this year in Sydney for the Asialink Sir Dunlop "Weary" Awards Dinner, I was impressed with how the event created a platform for Asian voices and recognition of Asian leaders in our Australian community. Our own colleague and current 2023 Branch Secretary, Matt Floro, was recognised as the recipient of the 2022 Legal Award. Presently our branch is in the works with esteemed Asialink patron Ms Susan Gin for

further multi-disciplinary collaborative opportunities in the new year.

As AALA continues to grow, our National Executive continues to adapt and work with each of its Branches and Membership to ensure that we continue to achieve our mission objectives. In recognising that AALA is a national organisation, completely run by dedicated and passionate volunteers, I extend my thanks to each and every active member particularly my colleagues on the NSW Committee. In addition to our full-time jobs, and our hats as parents, spouses, carers, students and so on, we also continued our impressive research arm and hosted dynamic and inspiring events. We have continued our work with key diversity stakeholder groups including Womens Lawyers Association NSW, Diversity and Inclusion Committee of the Law Society of New South Wales, the NSW Bar Association, various law firms and legal associations.

Key highlights of 2023 included:

- Branch President Dora Cheung and prior Branch Secretary Johnny Nguyen convening the National Mentoring Program, launching across all states from end of July to August 2023, program officially ending at the start of 2024.
- Launch of the National Mentoring Program for NSW on 8 August 2023, the NSW Branch launched the National Mentoring Program at the new College of Law City Campus with our Patron, Katrina Rathie, providing a very well-received keynote speech with a 60 plus turnout and many compliments from attendees.
- Celebration of 10 Years of AALA: on 1 September 2023, President Dora Cheung, Vice-President Michael Tangonan, and Committee Members Matt Floro and Ivonne Muryadi and NSW Patron Katrina Rathie attended the 10 Year Anniversary Gala for the organisation and the subsequent National Roundtables on 2 September 2023.
- CPD Events: as part of the March Madness CPD offering of the NSW Branch, two co-branded CPD events with Frederick Jordan Chambers were held including "Quistclose Trusts in 2022: a Year in Review" on 14 March 2023 presented by



Committee Member, Ronny Chen, and "Judicial Review of Migration Decisions" on 23 March 2023 presented by Nick Poynder.

- Publications: on 10 November 2022, the NSW Branch launched its "Cultural Diversity Focus Groups Project: Pilot Outcomes Report 2022." An industry-first in NSW, the Report was a crosscollaboration between AALA and Women Lawyers' Association with the support of King and Wood Mallesons and members from other organisations. The Report examined the perceived boundaries and challenges faced by solicitors from diverse backgrounds using both qualitative and quantitative methods and in particular, used focus groups as a methodology to profile the experiences of these solicitors. Led by NSW Committee Members, Lee-May Saw and Michael Tangonan, the Report was launched at a special launch event which welcomed keynote, Honourable Tom Bathurst KC together with an esteemed panel chaired by our Patron, Katrina Rathie. The Report has kickstarted an ongoing cooperation with University of Technology Sydney Law School who is undertaking a similar project directed to understand student experiences. Funding has been received from the Centre for Social Inclusion at the University of Technology Sydney with the NSW Branch named as the community partner.
- **Policy and advocacy:** the Branch provided a submission to the Multicultural Framework consultation by the Department of Home Affairs and continues to monitor opportunities to advocate, engage, and consult with public and government agencies.
- Branch President Dora Cheung attended Legal Aid NSW diversity events including launch of their diversity and inclusion staff organisation the CALD Network at the

Bankstown Arts Centre on the International Day of the Elimination of Racial Discrimination, and Diwali Celebrations in November 2023.

We started out without a Secretary, but were very fortunate to have Khami Aughterson fill that vacancy in early 2023, bringing into the Secretary role, her linkages with a range of academic, private sector, community sector, public sector and international contacts, reflective of the seniority and diverse legal career that Khami has had to date. - Clayton Utz for hosting our branch committee meetings.





#### Financial Reporting Framework

#### Statement of Compliance

#### **1 Summary of Significant Accounting Policies**

#### **Revenue Recognition**

The association adopted AASB 15: *Revenue from Contracts with Customers or Income* per AASB 1058: *Income of Not-for Profit Entities* during the year.

#### Membership Fees

Membership fees are recognised as revenue in the year to which they relate. When membership fees are received that relate to subsequent financial year, the amount received as contract liability is classified as liability.

#### Sponsorships

Sponsorships for functions and events are recognised once functions and events have taken place.

#### Function Revenue

Revenue from functions and events is recognised once they have taken place.

#### Interest Revenue

Interest revenue is recognised using the effective interest method.

#### Cash and Cash Equivalents

Cash and cash equivalents comprise of cash on hand, which are subject to an insignificant risk of change in value.

#### Intangible Assets

Website development costs are capitalised only when the website is able to deliver future economic benefits and these benefits can be measured reliably.

Website development costs are amortised on a systematic basis matched to the future economic benefits over the useful life of the website.
